City 6 Situation Recap

Juneteenth At Boys State

Juneteenth, a federal holiday celebrated yearly on June 19, commemorates the liberation of enslaved African-Americans as a result of the Emancipation Proclamation of 1862. Unfortunately, on Sunday morning, what was meant to be a joyous celebration of a milestone in American history quickly devolved into another example of gun violence's tragic consequences in our country.

CBS reported that at 12:30 a.m. yesterday in Willowbrook, IL, a suburb of Chicago, a party of over 200 attendees celebrating Juneteenth was abruptly interrupted by 20 to 30 gunshots fired into the crowd, leaving 1 dead and at least 22 wounded. Authorities have yet to determine possible suspects or motives.

Tragically, this is only the most recent occurrence in what has been a series of similar events over the past few years, emphasizing the urgency of action regarding gun control in our country. Gun violence is not an inevitable issue, and its resulting casualties in our country have been largely preventable. Gun reform is not and should not be a partisan issue, and our leaders must find a way to cross party lines and create a viable solution in order to prevent any needless losses in the future.

Landmark Supreme Court Case

The most recent decision made by the Supreme Court is incredibly significant, as it pertains to upholding a fundamental right of American citizens: the right to vote.

Argued in 2022, *Allen v. Milligan* concerned the representation of African American constituents in Alabama based on the number of black-majority congressional districts in the state. Due to recent gerrymandering in which the Alabama state legislature drew up new district borders, black constituents were left underrepresented. In order to proportionally represent the voters of Alabama based on population, the Court narrowly ruled 5-4 in favor of *Allen*, affirming that the previous districting map violated the 1965 Voting Rights Act.

In *Allen*, the Court not only reinforced a landmark piece of legislation, but also upheld the importance of voting rights for all Americans. The decision in this case, made on June 8, 2023, leads many legal scholars to believe that future challenges to unjust districting practices will be met with similar responses by the Court.

As statesmen who will learn more about the fundamentals of the judicial branch later this week, it is cases like *Allen v. Milligan* that remind us of the Supreme Court's key role of ensuring each American justice under the law.
